All candidates are intimated to produce & submit certificate issued by Tehsildar/Executive Magistrate/SDM regarding 'No Govt. job in family' under socio-economic criteria at the time of joining to department.

2. As per Govt. Instruction no 22/15/1992-3GS III Dated: 07.10.2008, if suitable candidates of ESP are not available in a particular category, then the vacancies be filled up from amongst the same category candidates

3. As per Govt. Instruction no 22/10/2010-1GS III Dated: 23.05.2014,if suitable candidates of Ex-Servicemen are not available in a particular category, then the vacancies be filled up from amongst the same category candidates.

4. "01 post of VH,01 Post of HH and 01 Post of Autism Category shall be carry forward due to nonavailability of suitable candidates.
