- For each of these disciplines, candidates may or may not opt to be considered for other institutes. In both the cases, single application with single payment is adequate.
- Candidates interested in applying for ICMR-NIE/ICMR-VCRC may refer the website of respective institute(s) for further details.
- If a candidate opts to be considered for more than one institute, order of preference should be given. The order of preference once given in the online application will be final and no further request for change will be permitted.
- Final appointment will be made subject to the merit list of the candidates and subject to the availability of posts under appropriate reservation points at different Institutes.

HOW TO APPLY

- Candidates should apply only through online mode, once the link is activated in the website.
- Valid email id and mobile number is mandatory for online application process.
- Application fee (non-refundable) of Rs. 300/- (**Three hundred only**) plus transaction charges as applicable is required. SC/ST, Persons with Disabilities (PwD), Ex-Servicemen and Women candidates are exempted from application fee. ICMR employees are not exempted from payment of application fee. Application fee is to be paid by candidates through online mode during the application process. The fee once deposited will neither be refunded under any circumstances whatsoever nor can the fee be held in reserve for any other examination or selection.
- Candidates interested to apply for different posts should submit separate applications for each post and pay the applicable fees separately.

SELECTION PROCEDURE

• Selection for the posts of Technical Assistant and Laboratory Attendant-1 will be through computer-based test only.

• The computer-based test will be of MCQ type with a total of 100 questions as given below:

- Questions from the subject matter will be of a level commensurate with the essential qualification.
- Total duration of the computer based test will be 90 minutes and total marks will be 100. Correct answers will be given a positive mark of 1 and wrong answers will be given a negative mark of 0.25.
- Candidates will be selected based on their merit in the computer-based test as per DoPT guidelines and subject to fulfilling all other eligibility criteria.

TERMS AND CONDITIONS FOR ALL THE POSTS

NATIONALITY

• The applicant must be a citizen of India.

AGE LIMIT

- The crucial date for determining the age limit shall be the last date of receipt of application for all the posts.
- Date of Birth filled by the candidate in the application form should be the same as recorded in the Matriculation / Secondary Examination Certificate and no subsequent request for change will be considered or granted.
- No age relaxation will be given to SC/ST/OBC (Non Creamy Layer) candidates applying for the unreserved posts as per Government of India order No.36011/1/98/Estt (Res.) dated 01.07.1998 as amended from time to time.
- Age relaxation to SC/ST/OBC (Non Creamy Layer)/PwBD/Ex-Servicemen etc. shall be considered as per the DoPT OM No. DoPT-1667569393892, dt.06.09.2022 as amended from time to time.
- The upper age limit is relaxed by 5 years for SC/ST, 3 years for OBC (Non Creamy Layer) candidates. It is relaxed by 10 years for PwBD-General, 13 years for PwBD-OBC and 15 years for PwBD-SC/ST candidates.
- Age relaxation for Ex-Servicemen: Unreserved-03 years, OBC-NCL-06 years (3 years + 3 years), SC & ST-08 years (3 years + 5 years) after deduction of the military service rendered from the actual age as on the closing date for receipt of application.
- Relaxation of age limit would be permissible to such persons who have a minimum of 40% disability. The candidate need to attach the relevant disability certificate, issued by the competent medical authority of the Government of India for claiming age relaxation failing which no age relaxation shall be considered (Annexure-V).
- Applications from employees working in the Central/State Govt. Departments/Autonomous/Public Sector Undertakings should be forwarded through proper channel.
- Central Government servants and departmental candidates who have rendered at least 3 years continuous service under the Central Government are allowed the age relaxation up to the age of 40 years (45 years for SC/ST) for appointment to Group C posts by direct recruitment subject to the usual conditions that the Group C posts to which direct recruitment is being made are in the same line or allied cadres and that a relationship could be

established that service rendered in the post will be useful for efficient discharge of the duties in other categories of posts (Annexure-VIII).

- Age concession of 5 years is allowed to Departmental Candidates and Central Government employees for appointment to Group B posts by direct recruitment subject to the usual conditions that the Group B posts to which direct recruitment is being made or in the same line or allied cadres and that a relationship could be established that service rendered in the posts will be useful for efficient discharge of the duties in the categories of posts (Annexure-VIII).
- Candidates working in the ICMR FUNDED PROJECT continuously shall also be eligible for age relaxation upto five years or equivalent to the project service rendered by them, whichever is less; provided he/she has entered into the project service within the prescribed age limit for the post for which they are applying. (Annexure-IX).
- Those ex-servicemen who have already secured regular employment under the Central/State government in civil posts after availing the benefit of ex-service man quota would be permitted the benefit of age relaxation as admissible for ex-servicemen for securing another employment in any higher post or service under the Central/State Government irrespective of any Group/Post. However, such candidates will not be eligible for the benefit of reservation, if any, for ex-servicemen in Central Government.

PROBATION:

• The period of probation will be Two years for all the posts from date of joining. Other terms and conditions regarding probation will be as per the rules of ICMR/GOI issued from time to time.

Special Instructions for PwBD Candidates:

- Reservations for persons with benchmark disabilities will be given as per the instructions contained in OM dated 15th January 2018 issued by DOPT, Ministry of Personnel, Public Grievances & Pensions, Govt. of India for reservation for the persons with benchmark disabilities.
- As per OM dated 15th January 2018 issued by DOPT, Ministry of Personnel, Public Grievances & Pensions, Govt. of India for reservation for the persons with benchmark disabilities, the persons selected against the quota for persons with benchmark disabilities will be placed in the respective category viz. SC/ST/OBC/UR/EWS to which they belong. They will have to compete as per standards prescribed for their respective category viz. SC/ST/OBC/UR/EWS.
- The applicant must have a valid Disability Certificate issued by the competent authority i.e. Medical Board duly constituted by the Central or the State Government. Certificate issued by the Medical Practitioner, Hospital or any other Institution will not be considered. The physical disability of finally selected candidates would be ascertained by a Medical Board specifically constituted for this purpose.
- Low vision candidates who wish to use magnifying glass will be allowed to use the same in the examination hall. Such candidates will have to bring their own magnifying glass to the examination hall.

OTHER TERMS AND CONDITIONS

- Category once filled in the application form cannot be changed and no benefit of other category will be admissible later on.
- The candidates belonging to SC/ST should submit the caste certificate in the prescribed format (Annexure-I).
- OBC certificate for the purpose of age relaxation will mean "PERSONS OF OBC CATEGORY NOT BELONGING TO CREAMY LAYER" as defined in DoPT's OM No. 36012/22/93-Estt (SCT) dated 08.09.1993, modified vide OM No. 36033/3/2004-Estt (res) dated 09.03.2004 and 14.10.2008 and subsequently revised vide OM No. 36035/1/2013-Estt. (Res.) dated 27.05.2013. The closing date for receipt of application will be treated as the date of reckoning for OBC status of the candidate and also for assuming that the candidate does not fall in the Creamy Layer on the reckoning date. OBC candidates must, therefore, furnish valid and updated OBC certificate in the prescribed format given in **Annexure-II** which should specifically include the clause regarding "Exclusion from the Creamy Layer". In order to get age relaxation, they have to furnish a declaration in the prescribed format given in **Annexure III**.
- The OBC certificate shall not be more than one year old from the last date of receipt of applications
- The OBC candidates who belong to "Creamy Layer" have to indicate their category as General.
- The candidates belonging to the EWS category should submit the Income and Asset Certificate in the prescribed format, as applicable (**Annexure-IV**). All the terms and conditions in respect of reservation for Economically Weaker Sections (EWSs) in civil posts and services in the Government of India shall be regulated in terms of DoPT OM No.36039/1/2019-Estt(Res.) dt.19.01.2019 and OM of even number dated 31.01.2019 as amended from time to time. The Income and Asset Certificate should be valid for the year 2023-24.
- The candidates belonging to the PwBD category should submit the Disability Certificate in the prescribed format, as applicable to them (Annexure-V).
- The candidates belonging to Ex-servicemen category should submit a Certificate from competent authority, as applicable to them.
- The candidates working in the Central/State Government Departments/Public Sector Undertaking etc. should submit "No Objection Certificate and Vigilance Clearance Certificate" failing which the application will be summarily rejected. (Annexure-VI).
- The Central Government Servants / Departmental Candidates and candidates working in the ICMR Funded Projects should submit "No Objection Certificate" in the prescribed format (Annexure-VII).
- All the posts carry all India transfer liability. The selected candidates may be posted at any of the Institutes/Centres/Field Units under the control of ICMR/ICMR-NIRT. No TA/DA shall be considered in this case
- Benefit of new structured defined contributory pension system is admissible for new entrants as per provision contained in the Ministry of Finance, Department of Economic Affair (ECB & PR Division), Notification No. 5/7/2003-ECB & PR dated 22.12.2003 effective from 01.01.2004.
- Any canvasing by or on behalf of the candidate or bringing political or other outside influence with regard to the selection/recruitment shall be treated as disqualification.
- The Experience Certificate (Work Experience) should be issued by the competent authority of the government recognised/approved/registered laboratory/institution etc. and must be clear with Name, Designation, Salary/Pay Scale drawn, period of work experience (From to), nature of duties performed etc. by the candidate.
- Educational qualifications should be from a recognised board/organization/institute of repute and experience should be in a government recognised/ approved/ registered laboratory/ institution.
