RESULT

Haryana Public Service Commission vide its Advertisement No. **Advt No. 32/2023** dated 24.06.2023 had advertised 240 posts of **Post Graduate Teacher (PGT) in the subject of Political Science for Rest of Haryana Cadre, in Secondary Education Department, Haryana.** The subject knowledge test was conducted on 17.09.2023 in which 481 no. of candidates appeared out of 567 total applicants. The Commission has finalized the result of the Subject Knowledge test. Candidates bearing the following Roll Nos. have been declared qualified for Interview/Viva-Voce provisionally, subject to the fulfillment of all other eligibility conditions.
